In addition, Hearing Distressing Voices kits are also available through the Criminal Justice Coordinating Center of Excellence and at additional locations around the state (NAMI, Cuyahoga County, etc.). This training helps mental health and law enforcement professionals understand the challenges that face people with psychiatric disabilities. During the training participants listen to distressing voices through headphones while completing a series of tasks. Afterwards, during the debriefing, even veteran mental health practitioners have reported gaining new insights into the strength and resilience of those with psychiatric disabilities.
