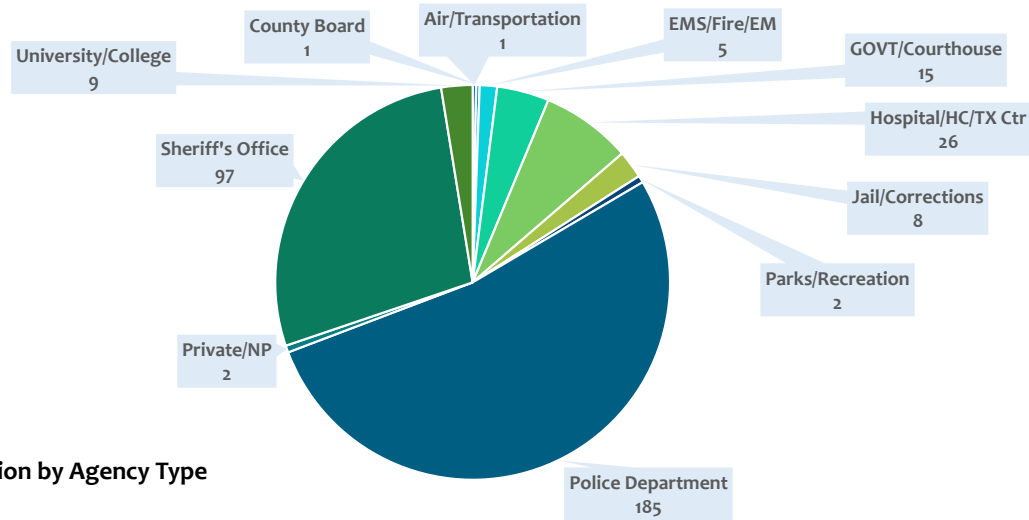
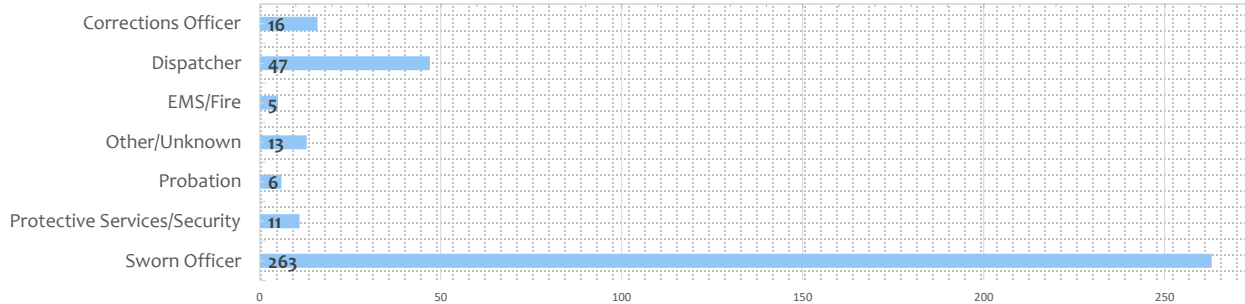




## Crisis Intervention Team Training Statistics for Fiscal Year 2020 2nd Quarter

### Overall in Detail

#### October

**Lorain County** – 18 Dispatchers attended a companion course from 6 agencies, and another 16 Dispatchers attended a companion course from 7 agencies.
