  - a. External grant award letter (dates & amounts included)
  - b. Personal bank statement (dated within one month)
  - c. Government letter (dates & amounts included)

### 4. Proof of Medical Insurance

Insurance must be compliant with State Department regulations regarding coverage.

#### PREPARATION OF NEW DS-2019

- a. With this information the Global Engagement Office will prepare a new DS-2019 form reflecting the extended period.
- b. Your request for an extension must be completed before the program end date as noted on your DS-2019 form.
- c. Please note that a new DS-2019 will be issued to reflect the new period of stay.
- d. The new DS-2019 document legally extends your J-1 visit as long as you remain in the U.S. If you have a spouse or child(ren) in J-2 status, their stays will also be extended.

## IMPORTANT INFORMATION

- a. **Medical Insurance** You must have medical insurance coverage during your complete stay in the U.S.
- b. **Valid Visa** If your visa has or will expire, there is no problem as long as you are in the U.S. Should you travel outside the U.S. during this new period of valid J-1 status you must apply for a new J-1 visa stamp in your passport with your new DS form.
  - 1. A provision in federal regulations, known as *Automatic Visa Validation* permits you to leave the U.S. and return on an expired vise under certain conditions.
    - i. Only applies on temporary visits to Mexico, Canada and adjacent territories
    - ii. Time out of the U.S. must be less than 30 days
  - 2. There is some risk involved and there are no guarantees that you will be permitted reentry to the U.S.
  - 3. If your current J-1 visa has expired, you will use the new DS-2019 to apply for a new J-1 visa stamp at a US Embassy or Consulate outside the U.S.
