#### Ohio CIT Program Coordinators: Leading the Success of CIT in Ohio

CIT (Crisis Intervention Team) arrived in Ohio in 2000. Since that time, CITs and CIT programs have grown and flourished across our state. CIT program coordinators have been central to that growth and play a vital role in improving outcomes when law enforcement interacts with persons in crisis. CITs and CIT program coordinators work to ensure that those experiencing a crisis in their community are treated with dignity, respect, and compassion.

But ...where did the CIT program coordinator role come from?

The first CIT model originated with the Memphis Police Department in Memphis, Tennessee, and was based on one individual agency with an identified coordinator. As CIT developed in Ohio beyond individual law enforcement agencies, it became clear that the mental health and recovery boards were central partners and in most instances, the logical coordinating entity to ensure that CIT training and relationships with the mental health system were available to and consistent for all participating police agencies in their catchment area. This organizational model allowed for investment and buyin from existing systems and room for individual law enforcement agencies to continue to have their own internal coordinators for their officers and jurisdictions.

This unique parallel model of CIT coordination – CIT program coordinators covering a mental health board catchment area with individual agency CIT coordinators as partners – has proven to be accidentally visionary for Ohio, creating capacity for growth across the state and an infrastructure that will aid in the ongoing development of a comprehensive crisis response system. Now, CIT program coordinators represent a variety of collaborative partners including local NAMI affiliates, law enforcement, mental health agencies, and mental health boards.

The CIT program coordinator is a unique position. For some, the responsibilities and tasks are woven into their existing duties that allow them more time to dedicate to CIT. In other programs, coordinators volunteer their time and struggle to manage these extra responsibilities. Either way, they are juggling many commitments while still advancing the goals of Ohio CIT programs. They lead a one-of-a-kind collaboration directly with law enforcement, mental health, and advocacy partners. They bring a culture of care, compassion, and empathy to the law enforcement community. They invest time and energy into these relationships and into their safety and wellness.

CIT program coordinators work to bring together community partners and leadership to collaborate and find solutions to challenging issues. They willingly engage in and encourage arduous conversations about their local crisis response system and about how their criminal justice and mental health systems can work together. While these conversations are not always successful, they persevere knowing that commitment to ongoing improvement and engagement is imperative to building relationships, strengthening crisis response systems, and sustaining CIT programs.

They ensure that the voices and experiences of those with lived experience, their families, and other advocates, are represented in CIT programs, training courses, and steering committees. The insights, feedback, and stories of people with lived experience have directly impacted the perceptions of law enforcement and crisis response partners. These stories help reduce stigma about mental illness, and their inclusion in CIT programs provides a crucial first-hand perspective that helps first responders relate to a person experiencing a crisis.

CIT program coordinators have a strong history of finding each other, offering guidance, and supporting each other. They share materials, stories, insights, resources, and information freely while welcoming new coordinators to their trainings, offering sample agendas and documents, and always collaborating as peers. They also can't work in a vacuum within their own communities. CIT program coordinators cultivate relationships with their area law enforcement agencies, mental health agencies, advocacy groups, people with lived experience, and increasingly with local Fire/EMS and other entities within their local crisis response systems. No CIT program coordinator or CIT program thrives without the support of these key partners.

The success of CIT in Ohio is in part due to the dedication, commitment, time, and devotion of CIT program coordinators across the state. Ohio's accomplishments could not have been achieved without their efforts over the last two decades. By following the CIT model and the Ohio CIT Core Elements, Ohio will continue to develop and enhance CIT programs across the state with the goals of improving outcomes and the safety of everyone in situations when law enforcement officers interact with persons in crisis. CIT programs will continue to increase understanding of, accessibility to, and improve responsiveness by our crisis response systems. With strong local leadership and partnerships, communities will continue to improve how they deflect or divert persons in crisis from the criminal justice system to treatment alternatives when possible. Communities will continue to transform crisis response systems to use law enforcement officers as first responders only when there is an immediate or imminent threat to safety or a serious criminal concern.

Ohio CIT programs and CITs will continue to do this because of the partnerships across Ohio, which have been fostered and grown by CIT program coordinators, who have each other as supports, cheerleaders, resources, and partners.


