

# Accelerated Family Medicine Track (AFMT) Application

The **Accelerated Family Medicine Track (AFMT)** is an academic track program at NEOMED. The track shortens medical school by one calendar year and provisionally admits students to a NEOMED-affiliated Family Medicine residency program at their date of acceptance to the AFMT. Once acceptance decisions are made, students who accept their position in the AFMT will have an adjusted graduation date.

## **Application and Interview Process:**

Students interested in applying for the AFMT must:

- Attend two information sessions with the AFMT leadership detailing all curricular components of the program.
  - Session 1: General overview of AFMT program (Aug-Sept)
  - Session 2: Detailed description of AFMT program with residency partners (Oct)
- Attend an advising session with the Assistant Dean of Students to discuss career goals and specialty interest in Family Medicine. (Dec-Jan)
- Visit the NEOMED-affiliated Family Medicine Residency Programs (Dec)
- Complete and submit this application form, including all requested materials
- Eligible students will be invited to interview with AFMT leadership in mid-February
- Students still deemed eligible will be advanced in the process
- Advancing students interview with all participating residencies in early to mid-March
- After interviews are completed, students who are still interested will submit a confidential list of residencies in order of preference, omitting any residencies student would not like to pursue further
- Likewise, residencies will submit a confidential list of applicants in order of preference, omitting any unacceptable candidates.
- Selection process will be done by NEOMED using an algorithm similar to the NRMP.
